

For example, for the Pediatric Health track, students with experience working with diabetes, hematology/ oncology, gastroenterology, pulmonology, neurology, and nephrology conditions is preferred. For the Neuropsychology track, students with testing experience working with seizure disorders, hematology/ oncology, TBI, and other neurological conditions in a pediatric setting is preferred. Experience working with children and adolescents rather than adult populations is necessary.
