Milestones in Faculty Development

Interviewers' Guide to Applicant Interviews: What's Right & What's Not?

Why address this topic?

Interview season spans the whole academic year when we consider the timeline for graduating students to interview for residency as well as the active residents interviewing for fellowships. This is an important topic to discuss because:

- While many resources are available for the applicant on what questions to ask, how to dress, how to behave,... fewer resources are available for interviewers
- Typically physician interviewers (particularly junior faculty) have no training interviewing applicants (they are trained in interviewing patients).
- A large portion of program fit and other high impact criteria is gathered from the interview experience
- Residency and fellowship interviews; while high impact; vary significantly across programs and specialties.

The Interview Process

Two main types:

 Structured: The structured interview has higher reliability, validity, and fairness and smaller group differences. The structure can be in the content or the process or both.

- Unstructured: Unstandardized with no scoring system.
- · A combination of both

What about "Fit"?

There is no standard definition of "Fit". It is programspecific. Two dimensions of "fit":

- Person-Organization fit: (Personality, attitudes, learning style)
- Person-Job fit: (Competency, knowledge, ability)

What about types of interview questions? - Two types:

- Behavioral: Past behavior predicts future behavior
- Situational: Pose a hypothetical situation and ask how they would respond. Intentions predict future behavior.

Tips for Interviewers:

- Read the application before meeting the applicant
- Create a comfortable atmosphere & introduce yourself and your role.
- Let the applicant know if you plan to take notes.
 Don't only take notes when something bad is mentioned

- ♦ Ask job-relevant questions
- Use both behavioral and situational questions

What's Right and What's Not?

- Avoid inappropriate questions (Race, religion SES, sexual orientation, family lineage, other personal information unless volunteered by the applicant or mentioned in personal statement then it is fair game)
- Avoid questions about other programs they applied to, ranking plans, etc...
- Be aware of negative body language (Rolling eyes, raining eyebrows,...)
- Avoid judgmental comments
- Complete the rating or scoring sheet immediately
- ◆ Program must share with applicants sample contract and appointment eligibility and visa criteria. This can be done with either physical documents or sharing a link to a website. NRMP recommends that programs obtain signed acknowledgement from interviewees these that documents have been shared with them.

Milestones in CME News

ACCME-Accredited CME Providers Can Obtain MOC 2 ABP Credits for their CME Activities

Historically, the American Board of Pediatrics (ABP) has given the opportunity to ACCME-Accredited CME providers to apply to get MOC Part 2 Approval for their CME meetings if the CME activity met certain criteria of having a built-in self-assessment component with a minimum pass rate. The Department of Medical Education has designed for the past three years two of its Board Review Courses; the General Pediatric Review and Self-Assessment (GPRSA) and the Pediatric Critical Care Self-Assessment (PCCMSA) to meet the ABP MOC requirements. Both of those courses are approved each for 28.5 CME Credits and 20 points of ABP MOC part 2 Credits.

The registration for the 2017 Courses is opened. The 20th Annual GPRSA and the 5th Annual PCCMSA courses will be held May 18-21; 2017 and are both approved for CME Credits and MOC part

What's New in CME and ABP MOC?

Starting January 2017; the ABP came up with new requirements that offer more flexibility to ACCME-Accredited CME providers to design CME meeting that are eligible for MOC part 2 Credit. The activity must meet specific criteria including:

- The ACCME accreditation criteria
- 2. Include a comprehensive evaluation component
- Learner assessment methods must be relevant to the activity and must have a passing standard
- Feedback on learner assessment must be provided to the learner with rationale

- No partial MOC Credit is allowed to be awarded. Learners must earn the maximum amount of credit
- CME Providers will be audited and must keep records of learners
- 7. Evaluation/ Assessment Methods may include: Case Discussion (with feedback), Written Responses, Audience Re-System, Quiz sponse (answers discussed), Table-top Exercises, Simulation, Manuscript Review, and Writing Test Items, among others.

The Department of Medical Education will be holding sessions to course directors and Faculty Development Sessions to give more information and discussion. In the meantime, catch the two MOC2 events that will be held in May 2017 and register now for one of the two board review courses.


