Milestones in State-of-the-Art Service and Training Opportunities Nicklaus Children's Hospital Surgical Trainees Have the Opportunity to Learn Robotic Surgery

In July 2016: Nicklaus Children's Hospital announced offering now Robotic Single Site Surgery for Children. Nicklaus Children's is among the first pediatric facilities in the region to offer robotic single-site incision surgery for children utilizing the da Vinci Xi® system. The technique offers a single incision minimally invasive surgical option for gallbladder or ovarian surgeries in children. This presents a unique training opportunity for our Pediatric Surgery and Pediatric Urology Fellows to be exposed to and learn state-of-

the-art techniques from expert faculty. This service will provide families with better surgical options for certain types of surgeries with less pain and recovery time, less missed school days, and less surgical scarring. Our fellows will certainly be at the cutting edge of training for the future of pediatric surgical techniques under the guidance of faculty such as Dr. Fuad Al Khoury.

Below are the Roles and Responsibilities of the GMEC:

The GMEC along with the Designated Institutional Official (DIO) have the authority and responsibility for the oversight and administration of the Sponsoring Institution's ACGMEaccredited programs, as well as responsibility for ensuring compliance with the ACGME Institutional, Common, and Specialty/Subspecialty-Specific Program Requirements, and the Sponsoring Institution's Governing Body.

The GMEC responsibilities must include:

A- Oversight of:

- The ACGME accreditation status of the Sponsoring Institution and its ACGMEaccredited programs
- The quality of the GME learning and working environment within the Sponsoring Institution, its ACGME accredited programs, and its participating sites
- The quality of educational experiences in each ACGMEaccredited program that lead to measurable achievement of educational outcomes as identified in the ACGME Comm o n a n d s p e c i a lty/subspecialty-specific Program Requirements
- The ACGME-accredited programs' annual evaluation and improvement activities
- All processes related to reductions and closures of individual ACGME-accredited programs, major participating sites, and the Sponsoring Institution.

B- Review and approval of:

- The institutional GME policies and procedures
- Annual recommendations to the Sponsoring Institution's administration regarding resident/fellow stipends and benefits
- Applications for ACGME accreditation of new programs
- Requests for permanent changes in resident/fellow complement
- Major changes in ACGMEaccredited programs' structure or duration of education
- Additions and deletions of ACGME-accredited programs' participating sites

- Appointment of new program directors
- Progress reports requested by a Review Committee
- Responses to Clinical Learning Environment Review (CLER) reports
- Requests for exceptions to duty hour requirements
- Voluntary withdrawal of AC-GME program accreditation
- Requests for appeal of an adverse action by a Review Committee
- Appeal presentations to an ACGME Appeals Panel.

C- Demonstrate effective oversight of the Sponsoring Institution's accreditation through an Annual Institutional Review (AIR)

- The GMEC must identify institutional performance indicators for the AIR which include:
 - Results of the most recent institutional selfstudy visit o Results of ACGME surveys of residents/fellows and core faculty
 - Notification of ACGMEaccredited programs' accreditation statuses and self-study visits.
- The AIR must include monitoring procedures for action plans resulting from the review.
- The DIO must submit a written annual executive summary of the AIR to the Governing Body

D- Demonstrate effective oversight of underperforming programs through a Special Review process.

- The Special Review process must include a protocol that:
 - Establishes criteria for identifying underperformance
 - Results in a report that describes the quality improvement goals, the corrective actions, and the process for GMEC monitoring of outcomes.
