Show Me the Money! The Reality & Challenges of GME Funding

History of GME Funding

Below is a timeline for the evolution of GME funding in the U.S.

- Early 1900s Training institutions & hospitals paid their own money to train residents
- 1965 The Social Security Act was created. Medicare & Medicaid GME funding was established to meet the demands of increase in insured. CMS had no limit for GME spending
- 1980s GME payment was reformed and Direct and Indirect (DGME & IME) medial education funding were created. Teaching hospitals became the soul source of care for the poor.
- 1994 Full funding was limited to Initial Residency Period (IRP) per resident, additional time (fellowship) reimbursed as 50% DGME (100% IME). IRP sets the number of IRP years based on the first residency started by a trainee.
- 1997 The Balanced Budget Act (PL105-33 Sections 4261 & 4263) placed a "cap" on the number of residents funded. No change in the cap since despite an increase in matriculation numbers, medical school numbers and sizes. The cap halted the development of residency programs for years

Free-Standing Children's Hospitals were not included in the funding allocation (since they do not see Medicare patients)

What Does DGME Pay For?

- Residents' stipends, benefits, vacation & leave
- Allocated overhead costs
- Must be ACGME-approved or pre-requisite for ABMS certification
- Trainees cannot bill
- Pays for time trainee spends at hospital and on-provider settings
- Per Resident Amount (PRA) is based on the 1984 cost estimate for each hospital with FTE Cap based on 1996 FTE count

What Does IME Pay For?

 Compensates hospitals for higher inpatient operating cost associated with being a teaching hospital and cost due to patient complexity related to DRGs

The Special Case of Free-Standing Children's Hospitals - CHGME

- Prior to 1999, free-standing children's hospitals received no GME funds
- In 1999 Children's Hospitals GME (CHGME) funding was established as a block grant from HRSA authorized in Section 340E of the Public Health Service Act (PHSA).
- CHGME is a discretionary appropriation, 5-year period authorization
- CHGME provides GME funding to 55 free-standing children's Hospitals
- CHGME Hospitals make up 1% of all hospitals, yet, they train 49% of all pediatric residents, and 74% of pediatric subspecialists and conduct 21% of all NIH-sponsored Pediatric research

- CHGME is provided to Children's Hospitals not on a per resident rate but as a lump sum grant whose amount is variable, not secured (dependent on reauthorization) and its proportion is impacted by FTE caps
- While Medicare GME funds continue to grow by 4% annually, CHGME funding will decline to 45% of Medicare GME by 2024
- Advocacy is needed in the future

What is Needed?

- More stable and predictable CHGME funding (CHGME was intended as a short-term solution)
- Lifting the residency cap or redistribution of cap
- Ensure strong pipeline of Pediatricians and pediatric specialists
- Advocate for more funding to meet the cost of living growth and the growth of programs

GME Funding in general is complicated, challenging, multifactorial, and requires reform, update, and revision with the first step needed is to bring equity to freestanding children's hospitals through a unified model for all teaching hospitals. This can only be achieved through continued advocacy

Two bills:

- 1. Resident Physician Shortage: Reduction Act of 2019 (S. 348)
- Community & Public Helaht Programs Extension Act of 2019 (S. 192)

"Education improves quality of care, and should be an element in the cost of care to be borne partially by the hospital insurance program, until the community bears the cost in some other way"





Lee Savio Beers, MD, FAAP, is the immediate past president of the American Academy of Pediatrics (AAP) after serving her term as the 2021 AAP president. Dr. Beers will be the keynote speaker for the Class of 2022 Graduation Ceremony scheduled for Friday June 10th; 2022.

Milestones in Community Advocacy

Dr. Beers began her one-year term as President of the American Academy of Pediatrics (AAP) on Jan. 1, 2021 in the middle of the pandemic. Dr. Beers is a Professor of Pediatrics and the Medical Director for Community Health and Advocacy at Children's National Hospital. She is the Founding Director of the DC Mental Health Access in Pediatrics program and Co-Director of the Early Childhood Innovation Network. She also oversees the Child Health Advocacy Institute's Community Mental Health CORE, a public-private coalition that serves as a catalyst to elevate the standard of mental health care for every young person in Washington DC.

She earned her Medical Degree from Emory University School of Medicine and completed a pediatric residency at the Naval Medical Center in Portsmouth VA. Prior to joining Children's National, she was a general pediatrician at the Naval Hospital in Guantanamo Bay, Cuba and the National Naval Medical Center in Bethesda, MD.

She received the Academic Pediatric Association 2019 Public Policy and Advocacy Award. She serves in a wide variety of leadership and advisory positions within the Washington DC community. Her clinical and research interests include adolescent pregnancy and parenting, the integration of mental health and pediatric primary care, the impact of adversity and stress on child well-being and advocacy education. She lives in Washington DC with her husband Nathaniel, and two children.
