Did You Know that HIPAA Has a Minimum Necessary Rule?

Minimum Necessary Rule is a key protection principle of the Privacy Rule that protects health information from being used, accessed or disclosed when it is not necessary or authorized. Under this rule. NCHS is required to have policies limiting the unnecessary and inappropriate access to and disclosure of any protected health information.

It is a violation of NCHS policy and the HIPAA minimum necessary rule to access medical records outside of treatment, payment or healthcare operations. Specifically, it is not acceptable to access your own medical record, your family's medical record that of your co-workers or patients for whom you are not actively involved in the care. Such activity will be subject to disciplinary action as outlined in NCHS policy and quidance.

Violation of this rule is governed by the <u>Disciplinary</u> Actions for Privacy and Information Security-Related Violations of Protected Health Information v.1 policy, which can be found in PolicyTech.

NCHS authorized personnel should only access the "minimum necessary" information needed to perform their job (physicians, nurses, administrative employees) including to provide treatment, facilitate payment of a claim, register a patient or for support of our health care operations.

HIPAA - Minimum Necessary Rule- 45 CFR 164.502(b), 164.514(d)

Take Away

Minimum necessary:

- ♦ Requires you to limit your uses, disclosures and requests for PHI to the minimum necessary to do your
- ◆ Employees may not utilize their NCHS access to look up their medical records, records of their family members, friends, or people whom they know. The Health Information Management (HIM) Department may provide records with written request or the patient portal may be used.

Your responsibility:

- ♦ Only request or access information needed to perform your job.
- Just because you have access to information and records doesn't mean you have the right to view everyone's record.
- ♦ Accessing records when there isn't a need to know is strictly prohibited and can result in disciplinary action up to and including termination.

LEADING ENGAGING VIRTUAL MEETINGS

25 Tips for Engaging Your Audience on Conference Calls







IL Make your workshop as engaging as possible! A dry lecture can put people to sleep or prompt them to check out fairly



When you get to the point where you think you may be over the top with your presentation, you're not quite there yet!







Make sure that you set your expectations with your audience. Identify key learning objectives so participants can self-check once the workshop is complete to see how much they learned.

Use your hands to be expressive and make sure your points are coming across to your participants



3. EXPRESS YOURSELF

5. SHARE SCREENS

4. SET EXPECTATIONS

Have all participants share screens to promote engagement.



Do a chat storm! Ask a question of the audience and have them drop the answer into the chat room as a message. This is a quick way to keep them engaged.

7. CHAT STORM

Provide opportunities for participants to connect. Take a moment and ask all of the participants to share their LinkedIn profiles in the chatroom



8. FACILITATE CONNECTION

6. ASK QUESTIONS



Advise your participants that they may be called upon to answer questions. This can serve to make sure everyone is paying attention.

9. SCREEN RECORD

Edit the recorded video after it's You can post it on YouTube and share the link with your participants or those that did not attend



10. BREAKOUT ROOMS

This is a great way to make a workshop engaging. Participants can learn a great deal from one another sharing experiences. Determine the number of breakout rooms and establish the number of people per room before breaking them out. The number of rooms is entered by the host.





When doing breakout rooms, advise your participants that it may take 20 to 40 seconds to break everyone out into a room, as well as to reconvene.

You can broadcast a 2minute warning to all participants when you are ready to reconvene from breakout groups.


You can also assign people to break out rooms prior to the meeting using the meeting setup. Or, have people rename themselves and break each person out into groups based on the renaming criteria they are



When you process the breakout, you will have people left in the room you are in. Be prepared to facilitate discussion, or manually assign these people to other rooms




