This year, the Pediatric Residency Program will be recruiting for 28 ACGME-Approved positions for the class


# Milestones in Training: Growing the MCH Pediatric Programs

In September 2010, Miami Children's Hospital Pediatric Residency Program and Pediatric Osteopathic Residency Program were the only Pediatric Programs in the State of Florida to be awarded two HRSA Grants through the Affordable Care Act (ACA): Primary Care Residency Expansion (T89). These 5 years grants, totaling **<u>\$4.769 million</u>** will result in expansion of the Pediatric Residency and Pediatric Osteopathic Residency Programs through the addition of five new positions per year for three years (Total of 15 new positions). This will result in innovative primary care endeavors and experiences.

# **ACGME Approves New Work Hour Standards**

**S**tarting July 2011, new work hour rules are in effect for all ACGME-Approved programs. The following is a summary of the new work hour rules:

- 1. Maximum Hours of Work per Week—80 hours/week averaged over a four week period, inclusive of all in-house call and all moonlighting.
- 2. Mandatory Time Free of Duty—Minimum of one day free of duty every week (when averaged over four weeks). Athome call cannot be assigned on these free days.
- 3. Maximum Continuous Duty Period Length:
- PGY-1 residents must not exceed 16 hours.
- PGY-2 residents and above may be scheduled to a maximum of 24 hours in the hospital.
- Effective transitions in care.
- No additional clinical responsibilities after 24 hours of con-

tinuous in-house duty.

#### 4. Minimum Time Off between Scheduled Duty Periods:

- A) PGY-1 residents should have 10 hours, and must have eight hours, free of duty between scheduled duty periods.
- B) Intermediate-level residents should have 10 hours free of duty, and must have eight hours between scheduled duty periods. They must have at least 14 hours free of duty after 24 hours of in-house duty.

5- Maximum Frequency of In-House Night Float—No more than six consecutive nights of night float.

#### 6. Maximum In-House On-Call Frequency:

 PGY-2 residents and above must be scheduled for inhouse call no more frequently than every-third-night (when averaged over a four-week period).

#### 7. In case of at-Home Call

- Time spent in the hospital by residents on at-home call must count towards the 80-hour maximum weekly hour limit.
- The frequency of at-home call is not subject to the every-third-night limitation, but must satisfy the requirement for one-day-in-seven free of duty, when averaged over four weeks.
- At-home call must not be so frequent or taxing as to preclude rest or reasonable personal time for each resident.
